Greetings, Clubwomen!

As we all get back into the swing of our fall meetings and routines, I want to begin by thanking GFWC Maine President Suzanne Raymond for entrusting me with the role of Chairman for the GFWC Signature Program. I am honored and will do the program justice, as I myself have experienced sexual violence while serving in the military. Military Sexual Assault is one of the Signature Program's focus areas, and this Chairman would be happy to come speak to clubs about my experience.

As we all know, October is Domestic Violence Awareness Month. The GFWC Success for Survivors Scholarship was created in 2012 to assist those impacted by intimate partner violence who are pursuing higher education. GFWC has awarded more than \$97,500 in scholarship funds and the program continues to flourish. If your club is interested in supporting the scholarship or referring an individual to apply, here are some important dates to note: October 2024, the scholarship application opens. February 2025, application deadline. May/June 2025, recipients notified.

The goal of the GFWC Signature Program is to increase awareness of and prevent the widespread occurrence of domestic and sexual violence in our communities. I would like to take a moment to highlight "Partners for Peace", a domestic violence organization in Bangor that has provided support, advocacy, and education to people impacted by domestic violence for the past 50 years. They are entirely funded by DHS, MHA and donations made by the public. I have personally known women that have used "Partners for Peace" and I was asked to write a letter a few months ago in support of the program, so that they may continue to be funded. Clubs may choose to support "Partners for Peace", or a similar organization in the State of Maine.

In closing, I want to thank all of you for your past support of this very important committee and I look forward to visiting your clubs and working with you to continue to do the great work needed to keep our citizens safe.




